IUPHAR INTERNATIONAL STUDENTS' POSTER COMPETITION

- All entries must illustrate and reflect the thematic issue of:
 "Clinical Pharmacology in the era of pandemics"
- Two competition entries:
 - General posters: open to all medical, pharmacy or pharmacology pregraduate students.
 - Research posters: open to all medical, pharmacy or pharmacology pre- and post-graduate students.

IUPHAR INTERNATIONAL STUDENTS' POSTER COMPETITION

General posters entry: Posters can be created through any medium (digital, illustrated, hand drawn/painted) but must be submitted digitally.

- Some examples: key messages on drug development, clinical drug research, warnings on self-medication and stopping medicines, medication errors, drug interactions and adverse drug reactions, pharmacovigilance, off label/compassionate drug use, supply management, misleading claims and fraud; vignettes (drawings and/or brief medical stories) with examples; emblematic drawing. Be creative!

How clearly does the abstract describe the work that was conducted?	Excellent (3): The title, abstract, hypothesis and objectives clearly describe the project.	Good (2): The abstract and objectives are generally described.	Fair (1): The title, abstract, hypothesis and objectives are unclear.
Are the methods sound?	Excellent (3): The abstract provides a clear description of appropriate and sound methods. Hypothesis and objectives are clear and well tested by the methods used.	Good (2): The abstract provides an adequate explanation of methods. There is room for improvement with proposed techniques. Hypothesis and objectives are moderately defined, appropriate, and testable.	Fair (1): The abstract provides an unorganized explanation or methods. Hypothesis and objectives are unclear and/or the methods used are not all appropriate.
Are the conclusions consistent with the results?	Excellent (3): The conclusions are based on solid results /or predicted based on solid methods.	Good (2): The conclusions are mostly supported by the results provided in the abstract, or the methods used will likely generate results that support the predicted conclusions.	Fair (1): The conclusions are weakly supported by the results or can only be partially predicted by the methods described.


